It establishes normative guidelines and a common conceptual framework for states to follow across a broad range of domains, including war, diplomacy, human rights, commerce, and environmental preservation.

International legal theory comprises a variety of theoretical and methodological approaches used to explain and analyse the content, formation and effectiveness of public international law and institutions and to suggest improvements. Some approaches center on the question of compliance: why states follow international norms in the absence of a coercive power that ensures compliance.

Just war, notion that the resort to armed force (*jus ad bellum*) is justified under certain conditions; also, the notion that the use of such force (*jus in bello*) should be limited in certain ways. Just war is a Western concept and should be distinguished from the Islamic concept of *jihād* (Arabic: "striving"), or holy war, which in Muslim legal theory is the only type of just war.
